

NOTICE

The Newark, Ohio Civil Service Commission will conduct an examination at the C-Tec Career and Technology Center, 150 Price Road, Newark, Ohio 43055, on October 14th, 2016, for the written exam at 1:00 PM, and on October 15, 2016, for the CPAT ability test at 9:00 AM, with a rain date of October 16th, 2016 at 9 A.M., for the entry-level position of Firefighter/Paramedic with the Newark City Division of Fire.

The Central Ohio Firefighter Testing Consortium will administer the ability test (CPAT) and the written examination.

The examination shall consist of two parts:

- **Part 1:** Written Examination (Which shall consist of 200 multiple choice Fire, EMS, and grammar questions). Candidates must achieve a score of 70% correct answers or greater to pass Part 1 of the examination process.
- **Part 2:** Candidate Physical Ability Test (CPAT)- Candidates must successfully complete the CPAT in 10 minutes and 20 seconds or less to pass Part 2 of the examination process.

Candidates must pass both portions of the examination (Written Exam & CPAT) to be considered for appointment to the position.

All testing, orientation, and practice sessions will take place at the C-TEC Adult Education Center, located at 150 Price Rd, Newark, OH 43055.

Minimum Requirements for Admission to the Tests:

- Valid driver's license
- - EMT-B Certification (West Licking Joint Fire District and Madison Township)
- -Level III Firefighter certification
- *Applicants must produce a photo ID at the location and date of the written examination and the physical ability examination.*

-To be considered for hire with the City of Newark, candidates must:

1. Possess an Emergency Medical Technician-Paramedic Certification or currently be enrolled in school for the same.
2. Candidates must obtain their Emergency Medical Technician-Paramedic Certification;
3. Complete a Questionnaire and have the same notarized, showing that the candidate is free of all disqualifying factors set forth in the Questionnaire;
4. Be at least eighteen years of age and no older than 36 years of age as of August 15, 2016;
5. Provide proof of graduation from High School or equivalent;
6. Provide proof that the vision requirements for the position have been met based on an eye examination performed within 90 days of August 15, 2016.

Registration Process:

Candidates must register directly with C-TEC to participate in the testing process. Candidates can register by calling C-TEC directly at 740-364-2280. None of the participating departments can register candidates for the testing process. **ALL FEES TO PARTICIPATE IN THE TESTING PROCESS ARE TO BE PAID DIRECTLY TO C-TEC**

ALL CANDIDATES MUST REGISTER NO LATER THAN AUGUST 15, 2016 AT 5:00 PM. TO PARTICIPATE IN THE TESTING. LATE OR INCOMPLETE REGISTRATIONS WILL NOT BE ACCEPTED

Candidates seeking extra credit for military service must file a copy of the DD214 Form with the Newark City Human Resources Department showing that they have been honorably discharged from military service.

THE CITY OF NEWARK WILL NOT PROVIDE NOTARY OR COPYING SERVICES. THERE WILL BE ABSOLUTELY NO EXCEPTIONS MADE IN MEETING THE APPLICATION FILING DEADLINE. IN THE EVENT OF INCLEMENT WEATHER, FOR THE PHYSICAL AGILITY EXAMINATION, YOU ARE STILL TO REPORT TO THE TEST SITE AT THE INDICATED TIME.
